FARMERS' INSTITUTE.

To be Held in Andover the 8th and 9th of February.

The Legislature of this State annually appropriates a sum of money to defray the expenses of sending competent instructors to different points in the State to hold Farmers' Institutes. For the past few years Allegany has been designated as one of the counties in which these Institutes shall be held, and this season the farmers of this vicinity are specially favored, as Andover has been named as the place in which to hold the Institute for this county. February 8 and 9 are the dates.

In addition to the instructors furnished by the State, there will be addresses and papers by well known and able residents of this county.

It will be a grand opportunity for the farmers of this county, and especially those living in this vicinity, to gather valuable information from the experience of others respecting methods in doing farm work.

Sad Death of a Little Daughter of Patrick Gallagher.
