The Washington correspondent of the Buffalo Express had an interview with Congressman Belden of New York, who says in regard to the political situation in this state:

"There is almost nothing doing yet, and I hardly know what to say about the situation beyond that I do not think either of the opposing candidates is particularly strong in New York. That is, neither excites a great amount of enthusiasm."

That is about the "size of it." Neither party can safely boast that it will carry the state, but the chances are a little in favor of—well, of the party to which you belong. We wouldn't be surprised to see one or another of the "third parties" gain some strength as a result of what might perhaps be called the general indifference. Of course, things are apt to warm up some before November.

There is one thing in connection with the affair at Homestead that strikes us as being somewhat incongruous. The Tariff Reform papers have all along claimed that the effect of Protection is to increase the price of everything on which there is a heavy duty. The products of Carnegie's mills are among the protected articles, and yet there has been a reduction in price on steel billets from \$28 to \$22.50 per ton. This is lower than the English goods could be sold here if they were admitted free of duty. And now the same papers say that the McKinley Bill is responsible for the Homestead trouble, because it caused a reduction in the price of iron and steel, and a consequent attempted reduction in wages. The fact is that American competition has reduced the price in this case as in others, and the question of high or low prices is simply a question of supply and demand. This may be Republican doctrine or it may not be, but it seems to us that it is common sense.

These votes added to the 169 which New Jersey and the South will certainly cast for Cleveland and Stevenson will elect them, no matter what New York and Connecticut may do.—Chicago Herald.

The great State of Pennsylvania with its 33 Electoral votes becomes an object of intense interest, with its 250 idle mills and from 50,000 to 75,000 anxious workmen disgusted at a sham protection of labor. That state gave Harrison a plurality of 79,458 over Cleveland in 1888, but it is by no means certain that these figures will not be more than overcome this year by the lamentable failure of the Republican party to fulfill its promises as to wages under Protection.—Boston Globe.
