Hon. S. M. Norton, Surrogate, was in town last Saturday. The matter of the will of the late Marsh Bundy was adjourned three weeks, when Judge Norton will again hold Surrogate's court in this place.

Dr. F. E. Comstock has appealed his suit against Benjamin Green of Alfred, which was brought to recover pay for medical services rendered to the defendant's wife. The case will now go to the General Term of the Supreme Court.
