The program will start at 10 o'clock and close in time for the contestants to return home the same day.

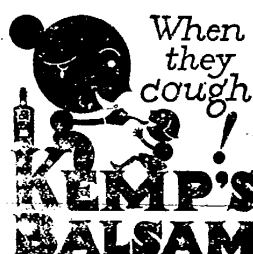
Awards will be made as follows:

PRIMARY ELECTION NOTICE

To the Enrolled Electors of the County of Allegany:

Notice is hereby given that a Primary Election will be held on the 1st day of April, 1924, in the several towns of the County of Allegany and State of New York, and that such Primary Election will be held open from twelve o'clock noon on that day until nine o'clock in the afternoon of that day for voting thereat.

The location of each polling place for such Primary Election in each election district in said county will be held the same as the polling place where the last General Election was held.

Each town in the County of Allegany shall comprise the same number of election districts as it did at the General Election held on the 6th day of November, 1923, and the boundaries of each election district in each of said towns shall be the same as those existing at that time. The Democratic, Republican and Socialist parties will hold their Primary Election at each of the polling places above described and all qualified enrolled electors may vote at such polling place in each election district in which he or she may reside.

Party positions for which candidates will be chosen and voted for by the several parties will be as follows:

Delegates and Alternate Delegates to attend the State Convention to be held at the time and place to be designated by each of said respective parties.

Congressional District Delegates and Alternate Delegates to the National Convention.

One Member of State Committee, County Committee and County Committeewomen in each election district in said county in such numbers as the rules of the several parties holding Primaries at this time shall prescribe.

CHARGES \$10 MINUTE FOR BROADCASTING

WEAF Has Exclusive Right to Levy Fee—\$100 Is Minimum Contract.

NEW YORK, Feb. 23.—The WEAF station of the American Telephone and Telegraph company now charges commercial firms at the rate of \$10 a minute for broadcasting, according to William E. Harkness, assistant vice president in charge of radio, and will probably charge political campaigns at the same rate this fall. The company sells broadcasting time only in ten-minute lots, so that the cheapest fee for broadcasting is \$100. The WEAF station is the only one requiring a fee for broadcasting. By its control of parents it is able to make charges and to prevent other companies from doing so.

"We have had no applications from politicians for broadcasting time so far," said Mr. Harkness, "and do not expect to have many." He said that after the primaries and conventions, when the candidates can deal directly with the public.

"At the best, I do not believe that much time can be surrendered from the regular program for political speeches. I don't think the audience will care much for it. A fair distribution of time will have to be made between the two parties."

Mr. Harkness said that no charge was made for religious services broadcast from the company's studios, and that the charge of less than cost was made to churches which needed special arrangements for broadcasting.
