Leon J. MacDonell, 75, a native and life-time resident of Bolivar, a Veteran Democratic Supervisor of the Town of Bolivar and prominent oil producer, died Thursday, Sept. 1, 1966 in Olean General Hospital after a long illness. Mr. MacDonell had served on the Allegany County Board of Supervisors and as chairman of the boards' Public Health Committee for the past 31 years. At the time of his death, he was also a member of the following standing board committees: Equalization and Apportionment, County Officers and Compensation, Charities, Finance, and Sales Tax. A veteran of World War I, he was a charter member of Kenyon Andrus American Legion Post and of the Bolivar County Club. He is survived by his widow, two sons and two sisters. Funeral services were held Sunday with burial in Maple Lawn Cemetery, Bolivar.

The Drake Manufacturing Company and members of Moore Lodge International Association of Machinists have agreed on a three-year contract calling for more than 40 cents per hour increase in wages and fringe benefits by the end of that period company President, Henry Macler has announced. Macler said that the settlement of the contract will allow the company to increase its employment from the current level of 80 to approximately 150 in the future.

The Keuka Lake water level was seven inches lower Friday than at the same time last season, and nine inches lower than the summer target level, the water level committee of the Keuka Lake Association reported.

Thruway motorists, beware of that airplane overhead—it may contain a state policeman checking your speed. The Thruway Authority has announced it would begin using rented airplanes to test their effectiveness in enforcing traffic laws. The pilots will use stop watches to time vehicles between highway markings and radio reports of violations to patrol cars on the ground.

Five freight cars of a west-bound Erie-Lackawanna train were derailed east of Canisteo at 9:15 a. m., Sunday as the result of a quick stop of the locomotive to avoid striking an automobile stalled on the tracks. The abrupt stop of the train buckled five cars loaded with iron ore and they left the tracks ripping up rails. No injuries were noted. The east-bound track was cleared and traffic resumed over that line following an eight hour delay. The west-bound line was cleared at 5 a. m., Monday.

Exemptions For Working Children

Do you have a student son or daughter who worked during the summer vacation and who earned \$600 or more?

If so, you are still eligible under certain conditions to retain the exemption deduction for your

child. The same holds true if you have a non-student working child who will still be under 19 years of age by the end of the tax year.

In either care, regardless of how much the child earned, the parent may claim an exemption, providing he has furnished over half the total cost of his child's support for the taxable year. This rule also applies in the case of legally adopted children.

There is one important thing to keep in mind. A dependent child is also entitled to an exemption deduction for himself on his own separate return. However, if he is married and files a joint return with his wife, no dependency exemption may be claimed by the parent.

John E. Foley, Buffalo District Director of Internal Revenue today clarified revenue laws which

have confused many parents.

"We have reports of both parents and employers telling working children they'll have to quit their jobs before they earn \$600. They can work right up to the reopening of school if they want to," the tax official said. "The children, however, may have to pay a small tax. Since many of them are studying our own courses in basic taxation, they already know this."

This information should prove helpful to three parties to summer employment, the student or child worker, the parents, and the employer, the Director said. He emphasized that to gain advantage of this rule, children 19 or over must be full time bona fide students at recognized educational institutions, or pursuing a full time on-farm training course.
