

### An Ugly Phoenix rears it's Head Again! An Editorial

During the recent public hearing on the Proposed County Budget while many questions were being asked by interested Taxpayers, an Altred Station Resident asked Benson Smith, Chairman of the Board of Supervisors, if they were considering a County Sales Tax. Mr. Smith admitted that it was under consideration and was then asked when — to which he answered: When the People are Ready for it".

As we recall, the Ugly Phoenix that publicly reared its head in the form of a County Sales Tax, was prematurely discovered and disclosed to our readers in June, 1962, by this paper. And, around a week later, the rest of the County Newspapers joined in with their protests against this insidious scheme to sneak a County Sales Tax thru before the public could have a chance to raise a protest against it.

A group of irate Citizens and Taxpayers hurriedly formed an organization called "COST" (Citizens Opposing the Sales Tax), and proposed that the tax be submitted to the people at election time for a referendum vote.

Within a couple of months, so many residents ir Allegany raised their voices in protest against the County Sales Tax that the proponents of this Tax withdrew their motions on the Four Sales Tax Resolutions and it was dropped.

At that time, James A. Young, Jr., Supervisor of the Town of West Almond who had seconded the original Sales Tax motion, stated: "My feelings have no changed. I still favor the sales tax but I do not believe this is the time to bring it before the Board".

Now, just four years later, this same Supervisor representing a Town of a total population of only 293 1960 Census), and where only around 40 voters went to the polls at the recent elections — strongly supported the inflated pay raises of several County Officials as well as the nearly \$5 Million Dollar County Budget. In fact, he even made the statement that he felt that the group of around 100 Citizens that protested at the County Budget Hearing last week were "Just a pressure group and didn't represent either Labor or Farm Or-
