JOINT PUBLIC HEARING OF THE VILLAGE BOARD AND THE TOWN BOARD OF ANDOVER, ALLEGANY COUNTY, NEW YORK, ON SUPPLYING GENERAL AMBULANCE SERVICE TO THE VILLAGE AND TOWN OF ANDOVER, NEW YORK, AND ENTERING INTO A CONTRACT WITH THE ANDOVER FIRE DEPARTMENT ASSOC., INC., TO OPERATE A GENERAL AMBULANCE SERVICE.

A joint public hearing will be held at the Andover Village Office on Main Street in the said Village of Andover, N. Y., between the hours of 8:00 P. M., and 9:00 P. M., on Tuesday, January 24th, 1967, by the Village Board and the Town Board of Andover, N. Y., on the question of supplying general ambulance service to the Village and Town of Andover and entering into a contract with the Andover Fire Department Assoc., Inc., to furnish general ambulance service within the Village and Town of Andover, N. Y., which ambulance service will be operated by the said Andover Fire Department Assoc. Inc.

That the cost of the said ambulance service, including the purchase of an ambulance and the equipment and maintenance of the same, is to be paid for by the Town and Village of Andover, N. Y., in the sum of Two Thousand Dollars (\$2,000.00), by the Town of Andover and Two Thousand Dollars (\$2,000.00) by the Village of Andover in the year 1967, and One Thousand Dollars (\$1,000.00) by the Village of Andover and One Thousand Dollars (\$1,000.00) by the Town of Andover in each of the years of 1968 and 1969. That the said proposed contract will be for the term of three (3) years for the years 1967, 1968 and 1969, and that the amount to be paid by the Village of Andover will be raised by a tax on the taxable property within the Village of Andover and the amount to be raised by the Town of Andover will be raised by a tax on that portion of the taxable property outside of the Corporation limits of the Village of Andover.

That the said ambulance service is to be operated as stated above by the said Andover Fire Department Assoc. Inc., who will supply the manpower to operate the same under contract with the said Town and Village of Andover, N. Y.

All persons residing within the Village and Town of Andover, or persons, firms and corporations owning real property within the area to be served, and all persons firms and corporations whose business interest or employment would either be benefited or adversely effected, and whether or not a resident or owner of real property in the area to be served, are requested to attend the said hearing and shall have the right to be heard in person or by a representative at the said hearing.
