ORDER TO SHOW CAUSE

Upon the annexed petition of Bayard C. Tullar, Edward W. Gent, Karney R. Cochran, Nelson A. Ingersoll and George B. Harris, Jr., being all of the Directors of Tullar Field Association, Inc., let the Attorney General of the State of New York, the members, creditors and contributors to the funds of said Association, and such other persons, firms and corporations as may be interested in these proceedings show cause before this Court, at a Special Term thereof to be held in and for the County of Allegany, at the County Court House at Belmont, New York on the 18th day of March, 1967 at 10:00 o'clock in the forenoon of that day, or as soon thereafter as counsel may be heard, why an Order should not be made and entered herein, pursuant to and in accordance with Section 56 of the Membership Corporation Law authorizing the Tullar Field Association, Inc. to transfer all of its funds and assets to the Village of Wellsville, New York and authorizing and directing the President or Vice-President and the Secretary or the Treasurer of said Tullar Field Association, Inc. to make, sign and acknowledge such instruments and do such other matters and things as may be necessary or desirable for the proper transfer of said funds and assets, and granting petitioners such other and further relief as may be necessary and proper.

Sufficient reason appearing therefor let service of notice of this application be made upon the members, creditors and contributors to the funds of the Tullar Field Association, Inc. and such other persons, firms and corporations as may be interested in these proceedings, by the publication of a copy of this Order once a week for four successive weeks in the Wellsville Daily Reporter and The Andover News, they being two newspapers of general circulation published in Allegany County State of New York, and that being the County in which the Treasurer of such Association resides, and it is further

ORDERED, that a copy of this Order to Show Cause be served personally, on or before February 6, 1967 on an officer or director of Woodlawn Cemetery Association, Inc., it being the only residuary legatee under the Last Will and Testament of the late E. F. Gee, formerly of Wellsville, New York, other than the said Village of Wellsville, New York, and it is further

ORDERED, that service of a copy of this Order, together with a copy of the papers upon which it is based, be made personally upon the Attorney General of the State of New York on or before February 6, 1967, by serving an Assistant Attorney General.
