District Director, William J. King of the Immigration and Naturalization Service estimated today that more than 20,000 aliens will report sheir addresses in the City of Buffalo during January under the Federal Alien Address Pagaram

Mr. King said that all non-cit
izens, except those in diplomatic
status and foreign representatives

dress report.

He added that any alten who willfully violates the address report requirement may be fined up to \$200, imprisoned for 30 days, and deported.

In addition, aliens who are not in the United States during Jan-uary must report their addresses to the Service within 10 days after their return.

#### Property Ownership Not Required For Public Office In New Bill

You will not have to be a property owner in a town, village or special municipal district in order to run for public office if a bill introduced in the Legislature to-day on the recommendation of Attorney General Louis J. Lef-kowitz is enacted into law.

The measure, which amends the Town Law and the Village Law, would eliminate sections of these laws requiring ownership of property as a qualification for election, appointment or continuace in certain offices and for voting on certain propositions.

"The sections of the Town Law

voting on certain propositions.

"The sections of the Town Law which relate to property ownership as a prerequisite for holding office were declared unconstitutional by the state Court of Anpeals last year and it is only proper that the law should be changed to remove these unconstitutional provisions", the Attorney General said.

"In striking down the provisions, the Court of Appeals stated that '— it is impossible today to find any rational connection between qualifications for administering town affairs and ownership of real property."

"Such a requirement, moreover, is archaic in modern day

tween quantitations for administering town affairs and ownership of real property."

"Such a requirement, moreover, is archaic in modern day society. In our rapidly growing towns and villages there are many former property owners who now live in rented premises and many young people who may be hirely qualified to serve in public office but who do not as yet own real property. To deny them the right to hold public office simply because they rent is unfair". Attorney General Lefkowitz said. Villages and special districts, including fire districts, would seem to be in the same classification as towns where the Court of propals declared unconstitutional a property ownership requirement.

The bill would change the village law which now provides that certain propositions must be submitted at a village election upon the petition of "owners of real property." The amendment provides that that where "multified operators" he substituted for "owners of real property."

School districts are not included in this bill because there are two alternatives to a property owner-ship requirement for holding of-fice on such boards,—that of being a renter of premises of parent of a child in school.

### The Politicans Giveth!!! And Taketh Away!!!

Four amendments of the State's Medicaid program, including reduction of the income eligibility levels to conform with recently enacted Federal mandates, were recommended by Governor Rockefeller this week to save an estimated \$92 million each for the State and localities in the next fiscal

The Governor submitted a \$5,494,000,000 Executive Budget for 1968-69 to the Legislature Tuesday, along with a program of tax increases etsimated to yield an additional \$494 million of

revenue.

In proposing Medicald revisions, the Governor cited the Federal cutback of eligibility standards which he said limits "the scope of Federal support for this program" and also a growing demand for Medicaid which has "put extreme pressure on available medical services."

"I am proposing," he said, "that "I am proposing," he said, "that the minimum income eligibility levels be reduced in accordance with Federal mandates and that different eligibility standards be provided for the Metropolitan New York area and the remainder of the State." The Governor also recommended. recommended:

recommended:

—Limited Medicaid benefits for those between 21 and 64 years of age, who do not qualify for them under Federal assistance programs, to inpatient care in medical institutions;

— Reducing from 20 to 25 per cent of annual income the savings permissible for a family qualifying for Medicaid under the incomeligibility standard;

— Requiring those not receiving

— Requiring those not receiving public assistance to pay 20 per cent of the cost for all median services except inpatient hospital

Estimating these recommende-tions would result in "holding down increases of State Medicaid

expenditures by \$92 million and those of localities by a comparable amount," the Governor said: "To make certain that no local-

To make certain that no locality is burdened with the effect of increases in the 1968-69 level of the Medicaid program above the 1967-68 level, I am recommending that the State assume responsibility for such increases through 'safe harmless' legislation."

### Did You Get The Wrong Car Registration Renewal

If you received a wrong punch card registration renewal appli-cation from the Department of

Motor Vehicles, the one which would have been for the car you sold several months ago, don't do anything right away. Wait a week or so—for you'll still have time—and you may get the correct card. The Department processes some 1,400,000 re-registrations each 12 months (that's when you shift from one car to another) and it takes time to get the new data on the computer. If the application still does not arrive by the 15th of the month of expiration, fill out a paper application. That'll do just as well.
