## Village Budget Hearing Held

The public hearing on the Village Budget was held Tuesday evening, Anril 9th and saw a rather spirited session with 7 local Taxpayers — other than the regular Board Members, Clerk and Attorney.

Several members present expressed their desire to see the Village Budget published another year so that prop set expenditures could be studied in advance and so that things could be discussed intelligently at the public hearing.

During the course of budget discussion several tempers flared with exchanges passed between Village. Attorney Sootheran and Taxpayers Clyde Harris and News Editor "Red" Allen, with Mayor Paul Kilbane also being included along with John Gavin. Mrs. Charles Canle and Jack Rosintoski also felt that a \$6 per thousand tax hike was rather excessive for retired people living on a fixed income.

Mayor Kilbane attributed most

Mayor Kilbane attributed most of the Tax Raise to the large amounts spent on the Village Dump this past year with the amount that will be needed next year. He also stated that he didn't feel that the number of people attending the budget hearing was representative of a large enough segment of the public to warrant any change of the items in the budget.

By the time that the discussion on the budget was concluded, it was generally decided that the deficits should, be taken care of budget-wise this year so that expenditures could get back on a level keel for next year.
