Speaking of snow reminds us that we received a bulletin from the State Police that should be of interest to all of you motorists that still have your winter - stud-

that still have your winter - studded tires on your car.
Here it is for your information
— and action: "If your car is
equipped with studded tires, they
should be removed by May 1 and
not returned to the vehicle before October 15th.
Superintendent William E. Kirwan has advised all State Police
installations that the use of studded tires between these dates is an
infraction and that enforcement

infraction and that enforcement action may be taken when viola-tions are observed. Ordinary snow tires without metal studs may be

tires without metal subsets at any time.

The limitation on the use of studded tires was incorporated in regulations issued in 1965 by the Public Public Property of Public Property of Pr former Department of Public Works, now the Department of Transportation, which authorized the use of these tires on state highways during the period when snow might create hazardous driv-

ing conditions.

The State Police has been asked by Commissioner J. Burch McMorran of the Department of Transran of the Department of Transportation to enforce the regulation as a result of a survey by department engineers which indicated that studded tires observed during the summer on passenger cars and delivery trucks had caused pavement deterioration in the Buffalo area".
