Village Board Member Dies From Accident Injuries

Charles S. Ruger, 6'L, Village Trustee and resident of Andover since 1839 childhood, dieditioning afternoon from injuries statistical in an uniqual accident while su-pervising Village street awaying activities earlier that days

According to a report from Wellsville-based State Police Mr. Ruger who was co-chaffining the Village Streets Department and Deputy-Mayor, was standing in the denter of North Main St. near the Street Junction of Rocciambeau, Ave., directing street cleaning operations when the tragic accident occurred.

Police said that he stopped a

Police said that he stopped a local motorist and after concluding the conversation, stepped away from the car directly into the path of the mechanical street-sweeper, operated by Charles J. Leonard, 35, of 96 Stevens St., Wellsville and owned by the Village of Wellsville.

The left front wheel of the sweeper passed over Mr. Ruger's legs, causing compound fractures of the right leg, severe lacerations and contusions, internal injuries and severe shock. The Andover rescue squad ambulance was sum-

and severe snock. The Andover rescue squad ambulance was summoned together with Dr., Alan Folsom and Mr. Ruger was rushed to the Bethesda Community Hospital in North Hornell upon his

pital in North Hornell upon his request.

The unfortunate accident occurred around 10:15 a. m. with the injured man lapsing into shock and passing away at 1:40 p.m. despits immediate surrency treatment and care upon his arrival at Bethesda Hospital, since his critical condition had been radioed ahead to the hospital by the Rescue Squad Ambulance.

The street sweeper is owned by the Village of Wellsville and the requiar operator had heen hired by the Village of Andover to speed up the street sweeping program.

Charles S. Ruger was born in Greenwood, Nov. 7, 1966, son of Kirk and Elizabeth Edwards Ruger. He had served on the Village Board since April 1959, Village Board since April 1909, and had recently been appointed Deputy Mayor by Mayor Paul Kilbane at the recent Village Board reorganization meeting.

Mr. Ruger had been a self-employed oil products distributor for many years in the Wellaville-Andver-Hornell Area.

He was a member of the Andover Methodist Church, Andover Chamber of Commerce, Andover Rod and Gun Club, and Andover Lodge No. 558, Free and Accepted Masons. He had served as secretary of the Hillside Cemetery Association for the past several years, and was a member of the local Boy Scout Committee.
