The conference will close with a worship service on Sunday morning at 10:00 where Governor and Mrs. Romney will address those attending the conference.

A LOCAL LAW TO PROVIDE-FOR WEIGHTED VOTING BY MEMBERS OF THE BOARD OF SUPERVISORS OF ALLF-GANY COUNTY ON AN INTERIM BASIS PURSUANT TO THE UNITED STATES AND STATE OF NEW YORK CONSTITUTIONS AND AN ORDER OF THE NEW YORK STATE SUPREME COURT.

BE IT ENACTED by the Board of Supervisors of the County of Allegany as follows:
SECTION ONE: Each of the

SECTION TWO: A total of 575 affirmative votes shall be required for the adoption of any resolution, local law, motion or proposal requiring a majority vote, and a total of 766 affirmative votes shall be required for the adoption of any resolution requiring a two-thirds vote.

SECTION THREE: The number of supervisors whose combined
vote will equal at least a majority
vote shall constitute a quorum
for the transaction of business,
but members with a lesser combination may-adjourn.

SECTION FOUR: This Local
Law shall become effective August
1, 1968, if prior approval is given
by an Order of the New York
State Supreme Court, and shall
remain in effect until January 1,
1970, unless either terminated
sooner or extended further by
law or by an Order of the New
York State Supreme Court.

LOCAL LAW PROVIDING FOR A PERMANENT PLAN
OF APPORTIONMENT FOR
THE ALLEGANY COUNTY
BOARD OF LEGISLATORS

BE IT ENACTED by the Board of Supervisors of the County of Allegany as follows: SECTION 1. Legislative Intent

The intent of this Local Law is The intent of this Local Law is to reapportion the Board of Supervisors of Allegany County in accordance with the so-called "one-man, one-vote" rule of constitutional law and, within the framework of this rule, to provide that there be a resident county legislator in each township-in Allegany County to be elected by legany County to be elected by the county at large. It is not the intent to negate the prime res-ponsibility of each county legis-lator which is to represent Allelator which is to represent Allegany County and its constituents to the best of his God-given ability, but to amalgamate traditional town representation on the old County Board with county representation on the new County Board, to the end that each county legislator can better serve the

citizens of Allegany County. SECTION 2. The County Board of Legislaters

be the elective governing body of
the County and shall take the
place of the Board of Supervisors.
The elected legislators shall, when
lawfully convened, constitute the
legislative, appropriating, governing and policy determining body
of Allegany County with all the

SECTION 3. Election and Term

SECTION 3. Election and Term of Office of Legislators

of Office of Legislators

County Legislators shall be elected at the general election held in each odd numbered year in such manner and in such numbers as hereinafter provided, the first such election to be held at the time of the general election in November, 1969.

The term of office of all county legislators shall be four years dating from January first of the year next succeeding their election, provided, however, that of the twenty-nine legislators first elected at the general election in November, 1969, fifteen, namely those legislators elected from among the resident-electors of the Towns of Alfred, Allen, Alma, Almond, Amity, Andover, Angelica, Belfast, Birdsall, Bolivar, Burns, Caneadea, Centerville, Clarksville and Cuba, shall be elected for a term of four years and the remaining fourteen legislators shall be elected for a term of four years and the remaining fourteen legislators shall be elected for a term of two years.

SECTION 5. Number and Manner of Selection of Legislators

The Board of Legislators of Al-The Board of Legislators of Allegany County shall consist of twenty-nine members, one to be elected by the County at large from among the resident-electors of each of the twenty-nine towns in Allegany County, resident-electors being defined as those persons possessing the qualifications set forth in Section 6 of this Local Law.

SECTION 6. Qualifications of Legislators

Each Legislator, at the time of his election or appointment and throughout his term of office, shall be a qualified voter of the Town in which he or she resides and shall have been a continuous resident of such town for at least one year preceding his or her election. year preceding his or her election.

No Legislator shall be eligible to hold at the same time any other elective county, town or village office.

SECTION 7. Primary Election for Legislators

Candidates to the office of County Legislator shall be nomine ated at the annual primary election held in each odd numbered year before the expiration of the term of office sought, commencing with the primary election to be

held in the year 1969. SECTION 8. Vess

SECTION 8. Vacancies

A vacancy in the office of Gamety Legislater shall be filled by the appointment, by a majority vete of the County Board of Legislators, of a person who possesses all of the qualifications required of members of the County Board of Legislators as set forth in Section 6 of this Local Law. The person appointed shall hold office by virtue of such appointment, until the commencement of the political year next succeeding the first annual election at which the vacancy can be filled by election, for the remainder of the unaxpired term, if any.

SECTION 9. Effect of Other

SECTION 9. Effect of Other Laws or Acts

Any law, general, special or local, or any ordinance, resolution or other act to the extent inconsistent herewith shall be superseded by the within law.

#### SECTION 10. Separability

If any clause, sentence, paragraph or section of this Local Law shall be adjudged by any court of competent jurisdiction to be invalid, such adjudication shall not affect, impair or invalidate the remaindor thereof, but shall be confined in its operation to the clause, sentence, paragraph or section thereof directly involved in the proceeding in which such adjudication shall have been rendered.

SECTION 11. Effective Date

This Local Law shall become effective only if approved by the affirmative vote of a majority of the qualified electors of the Counthe qualified electors of the County of Allegany voting upon the Local Law at the general election to be held on November 5, 1968; provided, that in the event an Order of the New York State Supreme Court requires that this Local Law be submitted to a special election on a date specified by said court, this Local Law shall become effective only if approved by the affirmative vote of a majority of the qualified electors of the County of Allegany voting upon the Local Law at said special election.
