The record of the 1968 session of the Legislature on gun control laws is a big, fat zero.

That is good or bad — depending on how you feel about gun control laws.

The Legislature even killed a bill outlawing the possession of Molotov cocktails. It passed the Democratic - controlled Assembly on March 5 and was sent to a committee of the Republican - controlled Senate — where it died.

The Legislative Index, official record of all bills filed in the Legislature, shows a total of 76 bills filed by various legislators dealing with amendments to the penal law in connection with weapons.

Of that number, it appears that only one passed both houses and was sent to Gov Reckefeller.

with amendments to the penal law in connection with weapons. Of that number, it appears that only one passed both houses and was sent to Gov. Rockefeller for his signature into law.

Gov. Rockefeller kept the record intact. He vetoed the bill.

That bill would have restricted the sale of ammunition for pistols to those who are authorized by law to possess a pistol.

One of the millor pieces of legislation this year was a Rockefeller program bill licensing rifles and shotguns. The bill was often used by reporters to liven up otherwise dull press conferences in hopes of stirring up controversy.

Actually, the governor gave it only half-hearted support. It died in committee in the Senate, and Assemblymen were spared the torture of having to go on record over it when it came out on the floor for debate and a vote.

As with children in school, there was a show of hands after the debate. The fluttering hands were apparently enough to defeat it (since the hands were never counted no one can know for sure) and the bill was sent back to committee — where it stayed.

Thus everyone was happy. Liberals could say, it got out on the floor and they debated for it. Conservatives could say they defeated it. Those lucky enough to hear and read the political speeches this fall will find this out.

Bills on both sides of the question died in committee.

A bill by Republican Assemblyman Edwyn E. Mason of Hobart, for example, would have exempted from the unlawful possession laws anyone who used a gun in self defense, the protection of property or who went to the defense of someone attacked or about to be attacked. It died in committee.

Democratic Assemblyman Francis J. Griffin of West Seneca filed a bill making it a violation of the law to display a gun in a store win-

Democratic Assemblyman Francis J. Griffin of West Seneca filed a bill making it a violation of the law to display a gun in a store window without first removing the firing pin or otherwise making it inoperable. That bill also died in committee.

Another bill would have put the National Rifle Assn. of America into the licensing business.

Filed by Republican Assemblyman Glenn H. Harris of Canada Lake, the bill would require an applicant for a pistol license to submit a certificate of qualification to handle the weapon. The applicant would be qualified by an agent of the State Conservation Department "may designate the National Rifle Assn. of America se the agent", said the bill, which died in committee.



Still another dead bill would have made it a misdemeanor to carry a loaded weapon in public, and another would have made it a misdemeanor for a person to find a gun and not turn it in to the police.

The present law modified to the died of the present law modified to the police.

The present law prohibits the sale of concealed weapons to anyone 16 years of age and under. Bills filed and killed would have raised the age to 19.
