Give Away Newspapers Can't Be Used For Official Advertising

A newspaper that's given away can't be used for official town ad-vertising, say State Comptroller Arthur Levitt.

The question arose when town officials asked if they could advertise in a paper that's reputedly mailed to everyone in town — for

"It is our conclusion," said Mr.
Levitt in answer, "that a 'pennysaver' type of advertising circular
is not a newspaper, despite the
reputed circulation."

This opinion extended to towns a view expressed earlier as to villages. In the Comptroller's view, "the absolute minimum requirements for designation of official newspapers" is that they be a newspaper, be established at least a year and have second class mailing appliedes.

In addition, he said, "due process requires the use of publications most likely to reach the persons interested in the notice".
And it has been held. Mr. Levitt noted, that where a person buys a paper he is more likely to read it than if he received it without charge.

Estimated Tax Changes

Individual taxpayers who have filed estimated tax declarations for 1968 and paid the first two installments are required to revise their estimates to reflect the new tax surcharge, John E. Foley, District Director, Internal Revenue Service, Buffalo, advised to-

enue Service, Buffalo, advised to-day.

He also pointed out that other taxpayers will become liable for filing estimated tax returns for the first time as a result of the tax surcharge. This is due to the requirement that generally, the difference in taxes withheld from individual income and income tax due for the calendar year must

difference in taxes withheld from individual income and income tax due for the calendar year must be less than \$40 or an estimated tax return must be filed. Since the tax surcharge will be withheld by employers for wages paid on and after July 14, 1968 and the surcharge is retroactive to April 1, 1968, the difference in taxes due from an individual income may be over \$40.

Individual taxpayers who are, presently filing estimated tax rejurns will be provided with a new worksheet form, currently being developed, when they are mailed their third estimated tax installment bill due September 15, 1968.

The current IRS rule permitting individual taxpayers to base their estimated payments on their tax liability for the preceding year 13 suspended, beginning with the installment due September 15, 1968.
Form 2210 for 1968 relating to the computation for underpayment of individual estimated tax will be revised to reflect these changes.

More Eggs, Fewer Farms Forecast By C. U. Prof.

There will be fewer poultry farms in New York State in years ahead, but egg production will

ahead, but egg production will continue to go up.

This was the forecast of Prof. Hollis R. Davis at the N. Y. State College of Agriculture, Cornell University, in speaking at the Poultrymen's Get. Together recently held at Cornell.

He said that the number of aggregated any form tripled in the

eggs sold per farm tripled in the 1959-1964 period, though the num-ber of farms declined about 50

per cent.

If this trend continues, egg production in 1969 may hit the 220 million mark, a more than 40 million jump from the 1964 output, he

lion jump from the 1964 output, he said. The number of farms may come down to around 3,600 from 7,364 in 1964.

Davis said eggs will be produced on intermediate-size farms housing anywhere from 10,000 to 50,000 birds. On the other hand, giant complexes operating from 100,000 to more than one million layers under one roof will become commonlace.

The large poultry farms, he noted, will be in excellent share from an engineering standpoint, but such complexes will run into many problems in terms of changes in ownership, management, and waste disposal.

Poultry houses will be prefabricated in shops and assembled quickly on the site. Environmental control will become much more refined. Building materials will be lightweight, made of plastics or plastic-protected materials.

The agricultural engineer also needicted that the flow of feed, waste, and waste in larger houses

segs, and waste in larger houses will be fully automated with the use of computerized memory units. Cage units will be made of new materials that will neither sag nor rust. They will be self-cleaning

nor rust. They will be self-cleaning.

Figgs will be electronically cleaned, sanitized, graded, and packed. The laying house will be monitored in a remote control room. Closed circuit television is already in use for observation of birds as well as for mechanical operations, he said.
