Greenwood Central School News

At the regular meeting of the Greenwood Board of Education held at the school on Monday, August 12 the following business of general interest to the public was conducted.

Mr Hoagtand reviewed briefly information that he had received from the Mt. Vernon school system to the problems with the New York State Education Department. The Mt. Vernon school system is asking for support from all schools to register disapproval of the state taking away local control from the local school district. A motion was made and userimously approved that the Greenwood Board of Education notify the Commissioner of Education and the political representatives in Albany advising that the Greenwood Central Shehool Board is unanimously apposed to any action by the State Education Department or the Legislature that would take away any of the local control and direction and responsibility that we now have for planning and directing educational programs.

Principal Hoagland was appoint.

Principal Hoagland was appointed Director for the Federal Program and was authorized to file a Title I report and application asking for a remedical reading program for the school year.

Jean Herrington, a fomer Home Economies teacher at Greenwood School, was authorized for employment as first grade teacher.

New report cards to allow for six week marking periods and need to be printed for this coming year and the Board discussed changes in reporting and honor roll marking. The board passed a motion to allow ¼ credit unit per year for physical education and to have honor rolls figured on a straight basis of marke and credit.

William Argenteri, Hornell, New York, was appointed school attorney and two matters of business relative to renewal of the school bonds and the regulation of the gates at the back of the school property were referred to the

action.

Mr. Hoagland reported to the

Board that our Federal Lunch Grant has not been renewed for 1968. This grant has allowed schools receiving it to reduce the price of lunches 5c below the regular price. In addition to this it will be necessary to increase the prices of lunches somewhat if the cafeteria is to operate on a breakeven basis. Until further notice the price of lunches has been set at K-6 — 25c — 7 - 12 — 30c and adult lunches — 40c. Ice Cream will continue to be included on the menu one day per week and extra ice cream will be available at 10c per serving. Extra milk at lunch time or for milk breaks in the grades will be available this year at the following prices: white milk 4c per bottle or 5 bottles for 17c. Chocolate milk will be available at 5c per bottle or 5 bottles Board that our Federal Lunch able at 5c per bottle or 5 bottles for 22c.

A resolution was passed to allow the school to dispose of old and obsolete records.

Bus transportation and routes for Bus transportation and routes for the coming year were discussed and Mr. Hoagland informed the Board that James Kernan had in-dicated that he wuld not be re-turning as he is presently employ-ed by the Town of Greenwood. Rodney Cook will be assigned to Bus 24 for the Bennetts Creek run and Clarence Stephens will be as-signed to Bus 27 for the Bush Hill route.

The monthly claims were authorized and the meeting was adjourned.


