How many of you people are getting really fed-up to the eye-calls with so-called progress? If as many of you subscribers are getting sick and tired of the inter-iuptions and conditions of the present local telephone service as we feel there are ______it sure seems we feel there are — it sure seems as if something could—and should be done about it! It's bad enough for business and

It's bad enough for business and professional people that rely on the phone service to conduct an important part of their business—like our Newpaper — local Doctor— etc, to have phone service disrupted by a so-termed "act of God" like a bolt of lightning — but when management is just satisfied to restore service—withiut making complete repairs, then, its about high time that — "we the people" demand some sort of satisfaction — and financial retribution!

When electrical service is disrupted due to a storm — or the like — the electric meters don't turn, so we at least don't have to pay for the service that we don't get. However, no matter how many days our phones are not in proper working order, we still have to pay the full price — for the service that WE DON'T GET!

The Public Service Commission lets the phone companies charge for their service a month in advance. So, it seems as if they should go along with the public — and let them deduct the cost from the telephone bills — for the days of service that the phones aren't in service working evaluation.


We can't think of anything more frustrating to the public — than to pay a big price for phone service that is supposed to be rendered — and then find out that many important business and personal phone calls have not been received because the out-of-town, and long bone calls have not been received because the out-of-town, and long distance callers haven't teen able to complete their calls. This, despite the fact that you have been stitting right on the phone all the time — and the darned thing just isn't ringing in properly. You sit there, refraining from making any calls to keep the line clear, and then when in desperation you finally pick it up to make a necessary local call — and the thing is dead — what an utter feeling of frustration! What if you were a Doctor — or a patient— waiting for an emergency call? Or a businessman — or a stranded motorist — trying to make an appointment, a reservation, or secure aid and assistance? make an appointment, a reservation, or secure aid and assistance?
And, when you finally arrive—
find that the person whom you
were trying to call was still sitting with a "sick phone" that just
hadn't rung in all day!
What possible retribution can
you demand for the anxiety caused? And then still have to pay
for the phone service— that

you demand for the anxiety caused? And then still have to pay — for the phone service — that you didn't receive! It really isn't fair to call up and give the Telephone Co. Employee "hail Columbia" that answers the repair service call — for something that they aren't personally responsible for. So, what then?

The only solution that we can see — is that if enough dis-satisfied subscribers report to management — or the Public Service Commission, enough justifiable complaints, that something might be able to be done.

So folks, if you are dis-satisfied, and want to do something — the line forms behind us!
