phone customers living in the Alfred, Almond and Andover area will be able to dial their long distance calls "direct" without operator assistance according to an announcement made today by Mr. G. E. Housen, Manager of the Iroquois Telephone Corporation's Alfred operations.

Mr. Housen said that this time saving method, called Automatic Number Identifications, is made possible by the recent addition of new equipment ordered from Stromberg-Carlson of Rochester "This latest improvement", Mr. Housen said, 'is a further step in bringing to the telephone user the most modern telephone facilities available. The addition (costing approximately \$45,000) is just one more step in our continuing effort to give the best in telephone service to our customers". "To access long distance, it will

"To access long distance, it will be necessary to dial 11 instead of the present 1", Mr. Housen said "for instance" he added, "to dial a Hornell call, you will dial 11 + the Hornell number beginning December 22 — for the calls beyond the 607 number area, you will dial 11 + the area code + the local telephone number".
