Assemblyman Walkley Reports

Amendments to the Taylor Law were passed in the Legislature with great emphasis placed on increased penalties, Assemblyman France and procedures provided in the amendments are of greater significance. Mr. Walkley said "Civil Service employees in our district do not want to strike. The improvement of relations between employer and employee is therefor much more important than penalties". penalties

matters, a code controlling improper practices, and public hearings as the mest important features in the revised law.
