Social Security News

Summer is a time for some social security reminders, according to Mr. Leonard J. Dziadkiewicz, manager of the social security

office in Olean, N. Y. Summer months mean a busy job for many of the young who have been in school up to now. If the new worker has not obtained a social security card in the past, he can save possible delay in starting work by getting his social security card before he reports for work. Summer is traditionally a season for weddings. Name changes should be reported to social security so records can be kept intact.

New changes in the law, making it easier for children to get benefits on their mother's record, makes it even more important for summer brides to keep their social security records straight. The reminder is: "When a Miss becomes a Mrs., social security records should be brought up to date."

A third reminder is for those who may be eligible for cash benefits in the summer months. Mr. Dziadkiewicz explained that an individual entitled to social security benefits can earn as much as he wants for the year and still receive a social security benefit for any month in which he has little or no earnings, or if he is self-employed, does little in his business. School teachers were cited as an example. They usually work ten months of the year. If a teacher qualifies for benefits he can be paid for the months he does not work, regardless of his total earnings for the other ten months. As a final reminder, Mr. Dziadkiewicz pointed out that the office at 153 North Union Street, Olean, N. Y., is open to give assistance in all kinds of social security matters. The hours are 9:00 A. M. to 5:00 P. M., Monday through Thursday and until 7:00 P. M. on Friday.
