LIVING UNDER LAW

DOUBLE JEOPARDY Most likely you can't picture yourself being brought to court on anything worse than a speeding violation. Nearly everyone feels that way. Even so, it is good to know that in this country you can't be made to stand trial twice on the same criminal charge.

There is a provision against double jeopardy. That is one of the important safeguards in our system of law which makes it certain that once a court has reached a verdict of "not guilty", the acquitted person may not be put on trial again for the same offense.

This right holds good, however, only if a full trial is held and a verdict is reached. It is possible to face another trial on the same charge if the first trial ends with a hung jury or a mistrial or if a new trial is requested or if the judgment of acquittal is reversed by an appellate court.

the state Supreme Court on appeal by the state. A classic example comes from the "Wild West" in the 1860's. A man named Ball was charged with murder along with two others. Ball was acquitted, but the other two were found guilty. The guilty pair appealed to a higher court, and their original indictment was found to be faulty.

Once again the government accused all three men. Ball claimed his right against double jeopardy had been invaded, and the U. S. Supreme Court agreed. He didn't have to stand trial again. The other two did, and paid the penalty for their guilt.

The reason for the double jeopardy provision is to protect the individual from being hounded all his life. In Old England, where the fear of tyranny first prompted safeguards for personal freedom, one court said: "Were it not for this rule, anyone obnoxious to the government might be run down by repeated attempts to carry on a prosecution against him."
