Public Hearing Print To Fit Held On Water Rate Increase

The regular meeting of the Andover Village Board was held at the Village Office, Monday night at which time the duly scheduled Public Hearing on the proposed increase in water rates was conducted.

Ten interested residents and taxpayers attended the hearing which was introduced by the following statement submitted by Mayor James Mulholland:

It is the feeling of this Village

It is the feeling of this Village Board that due to the various problems brought to our attention in the Water Department through interested consumers and the fire underwriters' report that it is time to establish and maintain a time to establish and maintain a permanent improvement program in our Water Department. The members of the Board are most concerned with the building of a depletion fund for future replacement needs. Such a fund should be established and maintained. It is not our intention to use the increased revenue (approximately \$4,000.00) for pay raises, etc. This increase in revenue will be used only for permanent improvement programs. We realize it imposes an extra cost to all of us, however, it is felt by this Board that it is a worthwhile investment of our cusworthwhile investment of our cus-tomers' money not only for them but also for the future needs of the residents of the Village of

Andover.

In question as to what our problems are, I would like to read excerpts from the New York Fire Insurance Rating Organization report of November 20, 1967:

port of November 20, 1967:

1. They state that our sup ply works are inadequate to furnish accrage daily consumption plus recommended fire flow for suggested duration. 2 Consideration should be

2. Consideration should be given to the installation of additional sources of supply, pumping equipment and/or elevated storage to provide, in addition to consumption needs, an eight (8) hour fire flow of 2,000 gallons per minute in the principal business section. ness section

Automatic controls should

3. Automatic controls should be installed, set 10 operate the well pump to maintain the distribution reservoir at capacity.

4. They state that our "arterial distribution" system is inadequate and incomplete. The distribution system should be strengthened to provide the minimum required fire flow of 500 gallons per minute at 20 pounds residual pressure from any hydrant on the system.

5. The valves in our system are spaced too far apart in many

are spaced too far apart in many

are spaced too far apart in many areas

6. New installation should be made with AWWA approved hydrants having at least two (2). 2½ inch outlets and one (2) large pumper outlet. Connections to street mains should be not less than six (6) inches in diameter and individually valved.

7. They further report that this inspection was made only to determine general adequacy and reliability of the system. They strongly indicated the need for an updated engineering study and the drawing up of an improvement

With this report in mind, we feel that the first step to better our present system is to hire a Professional Engineer to investigate these problems and draw up for us a permanent improvement program: By following a Permanent Improvement Program this ent Improvement Program, this Village, in due time, could solve many of its present water prob-

Please keep in mind that we will be investigating any and all possibilities of obtaining State or Federal assistance in this program.

After the above message was presented a discussion period was held followed by a poll of the people present at the meeting which showed a 100% agreement of the proposal as presented.
