"In beginning a talk to the

Revised Schedule Of Drug Prices Now In Effect

A change in the method of reimbursing pharmacists for drugs provided to medical assistance recipients has been approved by the State Division of the Budget, it has been announced by the State Health Department. The revised schedule of drug prices took effect Saturday (November 1).

The new schedule was necessitated by federal regulations applicable to the Title XIX (Medicaid) program. The traditional system of cost plus a percentage markup for setting retail prices will be replaced with cost plus a dispensing fee of \$1.80.

The fee of \$1.80 is to be added to the wholesale cost of the drug for all prescriptions that require compounding by the pharmacist; for all "legend" drugs (those available only by prescription) and for non-prescription drugs when the physician has written specific directions which differ from those on the original container, or when the prescription requires a quantity of medication other than that in the unit or package size.

For non-legend drugs generally, pharmacists charges shall not exceed the wholesale cost plus the usual markup, less 20 percent of

usual markup, less 20 percent of the markup.

The present minimum charge of \$1.50 for prescription drugs and the existing schedule of compounding service charges, will no apply after October 31. The pricing schedule for sickroom supplies, other than drugs, will remain unchanged at current wholesale cost plus a 40 percent markup.

The schedule of charges applies only to drugs, and supplies revided to persons receiving medical care under publicly financed programs and is a maximum schedule under which State aid is made available to local Social Sorvices districts. cial Services districts.
