LOCAL LAW NO. 2 of 1969 LOCAL LAW TO ESTABLISH DEPARTMENT OF PLANNING AND THE OFFICE OF DIRECTOR OF PLANNING

BE IT ENACTED by the Board of Supervisors of the County of Allegany as follows:

SECTION 1.

Department of Planning.
There is hereby established in and for the County of Allegany a department of planning. SECTION 2.

Director of Planning; appoint

ment and term of office.

There is hereby established the office of director of planning. The director shall be appointed by the board of supervisors of the (of Allegany for a term of four

SECTION 3.

Director of Planning, power and

duties.

The director of planning shall be the head of the department of planning and shall be vested with authority, direction and control over said department, and have the power and authority to appoint and remove officers and employees therein. He shall perform such duties as may be required by law and shall perform such additional duties as may be prescribed by the Board of Supervisors. In addition, he shall coordinate his services with the functions performed by with the functions performed by the Allegany County Planning

SECTION 4

Director of Planning, ...i.
The Director of planning shan
receive an annual salary to be
fixed by the Board of Supervisors. SECTION 5. Effective Date

This local law shall become of fective upon the date it is filed with the Secretary of State.
