Andover Gas Firm Authorized Use Of **Emergency Gasline**

Albany — In an emergency action aimed at minimizing hazards action aimed at minimizing hazards which could result from pressures which are building up in a Steuben County gas well which started flowing prematurely, the Public Service Commission today authorized Joyce Pipeline Company, of Andover, to utilize, until March 31, 1970, some 17,000 feet of high-pressure transmission line which will interconnect that well and the transmission princine of

which will interconnect that well and the transmission pipeline of Home Gas Company.

The well involved is located in the Town of Hartsville in Steuben County. The connection with the Home Gas pipeline is in nearby West Greenwood.

The well was drilled under authority of the Conservation Department. The gas strata was struck at a level substantially above that which had been anticipated with the result that gas began to flow from it before casing could be installed. Information gan to flow from it before casing could be installed. Information filed with the PSC indicates that the well blew for about one week before it was possible to install casing and to cap it on a temporary basis.

Meanwhile, Joyce Pipeline has a fear that a hazardous condition

Meanwhile, Joyce Pipeline has a fear that a hazardous condition will exist unless the present tophole, shut-in pressure of the well is relieved by delivery of gas to the Home pipeline.

To make that possible, Joyce has constructed a 17,000 foot high-pressure transmission line and applied for PSC authority to use it on a temporary basis because of emergency conditions.

Before acting on the petition PSC staff personnel inspected the line and directed the company to bury 200 feet of it on each side of two road crossings as a safety

The company is further required to test the pipeline at an exceptionally high pressure for at least 24 hours before gais allowed to flow through it. Field inspections have indicated that there are no structures in close proximity to the temporary emergency line.

In addition to a requirement that the pressure test be executed satisfactorily, the PSC is requiring Joyce to maintain a weekly walking inspection of the line since most of its 3.2-mile length will be above ground and to file weekly reports histing current wellhead pressures, delivery pressures, volumes delivered, and observations based on the walking inspections.

The company will be required however, to place its line underground in strict conformity with PSC regulations as soon as the present emergency conditions are ended but not later than next March 31.

The Commission's grant of the temporary authority to use the emergency pipeline was by a four-to-one vote with Chairman James A. Lundy and Commissioners Frank J. McMullen, Edward P. Larkin and John T. Ryan in the affirmative. Commissioner Ralph A. Lehr dissented.
