School Bus and Truck Collide

The new Andover Central School Bus, driven by Oliver Kemp, Bus Supervisor, collided with a pick-up truck around 11:00 p. m., Tuesday night on the way home from a basketball game at the road junction in Alfred Station where Route 244 from Alfred work. Payte 21

According to the accident report, the pick-up truck, driven by Roy L. Harding, 52, R.D. 2, Angelica, pulled out from the wrong lane of the traffic island there at the road junction directly into the bath of the School Bus.

Mr. Kemp, driver of the School Bus, reported that despite the fact that traffic on Route 21 has the right of way, he still slowed down when he noticed that the other vehicle was in the wrong lane of traffic only to have the other driver pull out directly into his path when it was too late to avoid a collision. collision.

None of the students were reported to have been injured, but the driver of the pick-up truck. Roy L. Harding and his passengers Reuben Harding, 65, also of Angelica, were taken to Jones Memorial Hospital suffering from minor

injuries. injuries.

Only superficial damage was done to the School Bus consisting of a bent bumper, grille, radiato and fan while extensive damage was caused to the left side of small truck.

State Police said the accident occurred when the Harding pickup truck, eastbound on Route 244, failed to stop for a stor sign at the road junction of Route 21 and vulled into the path of the southbound School Bus.

According to reports, Roy L Harding, driver of the truck. was issued a summons for: driving on the wrong side of a traffic island, failure to obey a stop sign, and failure to yield the right of way.

Provisions of Gun Law Defined By IRS Official

Defined By IRS Official

"The Gun Control Act of 1968 was passed by Congress to help Federal, State and local law enforcement officials in their fight against crime and violence", Philip E. Kopstein, IRS Alcohol, Tobacco and Firearms Chief Special Investigator for New York State said today, adding that it was in no way intended to hinder the activities of hunters and sportsmen.

As an example, Mr. Kopstein said hunters and sportsmen can purchase ammunition in any state and likewise can carry their own firearms across a state line as long as they are not convicted felons or under indictment for a felony fugitives from justice; unlawful users of drugs; or mental incompetents.

Further Mr. Kopstein said hunt-

users of drugs; or mental incompetents.

Further, Mr. Koostein said hunters, sportsmen, competitive shooters, or anyone legally using a gun in a state other than his home state can acquire another firearm if his rifle or shotgun is lost stolen or becomes inoperative.

He said the law requires only that the buyer in these circumstances make out an affadavit for the dealer's records, and provide the dealer with the title of the chief law enforcemnt officer in the locality where he lives.

All soil and water conservati.. measures being installed by farmers under the 1969 Agricultural Conservation Progam (ACP) must be substantially completed by the end of the year, according to Stephen Clarke, Chairman of the Allegany County Agricultural Stabilization and Conservation (ASC)

zation and Conservation (ASC)
Committee.

He urged farmers to complete their conservation work as soon as possible: Sometimes a man will plan to get the work done in November or December, and ther had weather holds him up. First thing you know it's New Years' Day, the ACP work isn't finished and the ASC Committee can't approve the Federal share of the costs, Clarke said.

He also reminded farmers tha' whenever a request for cost-shares

He also reminded farmers that whenever a request for cost-shares under the ACP is approved, the ASC Committee sets a commistion date for the practice. If a farmer is unable to report the conservation practice completed by the date set, he should request a time extension and explain why it is paeded.

Under the ACP, the Federa'
Government shares with farmers
the costs of conservation practices
needed in the public interest.
Farmers requests for cost-sharing
are administered by the ASC County Committee.
