Local Law No. 1 of 1971

A LOCAL LAW TO SUPPSEDE THE PROVISIONS OF SUBDIVISION OF SECTION SIX OF SECTION TWO HUNDRED FIFTEEN OF THE COUNTY LAW IN THAT PART OF THE COUNTY OF ALLEGANY IN THE TOWN OF ANGELICA

BE IT ENACTED by the Board of Legislators of the County of Allegany as follows:

SECTION ONE: Notwithstanding the provisions of subdivision six of Section two hundred fifteen of the County Law, real property owned by the County of Allegany in the Town of Angelica, or any portion thereof, may be sold or leased to private persons or corporations, without advertising or competitive bidding, upon such terms and conditions and in such manner as may be determined by resolution of the Board of Legislators of Allegany County.

SECTION TWO: This Local Law which is subject to permissive referendum shall become effective upon the date it is filed in the office of the Secretary of State.

This law was filed in the Office of the Secretary of State on January 8, 1971.

Local Law No. 2 of 1971

A LOCAL LAW ESTABLISHING THE ANNUAL SALARIES OF CERTAIN COUNTY OFFICERS.

BE IT ENACTED by the Board of Legislators of the County of Allegany as follows:

SECTION ONE: Commencing January 1, 1971 the annual salary of the Commissioner of Social Services shall be the sum of Thirteen Thousand Eight Hundred Eighty Dollars (\$13,880.00).

SECTION TWO: Commencing January 1, 1971 the annual salary of the Director of Planning shall be the sum of Thirteen Thousand Two Hundred Dollars (\$13,200.00).

SECTION THREE: Commencing January 1, 1971 the annual salary of the County Superintendent of Highways shall be the sum of Twelve Thousand Two Hundred Dollars (\$12,200.00).

SECTION FOUR: Commencing January 1, 1971 the annual salary of the County Attorney shall be the sum of Twelve Thousand Dollars (\$12,000.00).

SECTION FIVE: Commencing January 1, 1971 the annual salary of the County Treasurer shall be the sum of Eleven Thousand Seven Hundred Dollars (\$11,700.00).

SECTION SIX: Commencing January 1, 1971 the annual salary of the Commissioner of Jurors shall be the sum of One Thousand Three Hundred Fifty Dollars (\$1,350.00).

SECTION SEVEN: This Local Law, which is subject to permissive referendum, shall take effect upon the date it is filed in the Office of the Secretary of State.
