



State Senator Jess J. Present Reports

The high cost in time and money to personally answer by mail the several thousand persons communicating on the state budget and tax proposals with Senator Jess J. Present (R-Jamestown) rules out the usual courtesy of an individually dictated and typed response. The Senator has stated:

"It has been my practice, except in extreme cases, not to respond individually to persons writing to me on state matters" he said. "But I have reluctantly concluded that the recent deluge of mail on the subject of taxes and the budget must temporarily alter this line."

"I am asking the news media of our area to please publish this apology to the many, many people who have taken the time to write, petition or otherwise make known to me their views on this important subject."

"The many views bearing on a multitude of pertinent budget subjects have heightened my awareness and confirmed by concern with problems facing persons on fixed incomes, especially the elderly; low-income families; young families struggling to secure their own home; businesses and industries burdened by taxes, and local governments fighting to afford essential services."

"Many, too, have been the requests for attention to state services in the areas of social services environment, schools, colleges, hospitals, mental hygiene, transportation, agriculture, conservation and law enforcement."

"Few areas of public concern have escaped comment."

"Every communication has been carefully read and properly cataloged as to its content for reference in the decision-making facing me as I attempt to responsibly and respectfully serve this three county district."

"The concerned correspondence has been a great help to me and I wish to thank everyone for it. It is my intention to seek solutions to our problems keeping in mind the best interests of both our great state and my constituents," Senator Present said.
