A Message Print To Fit From Your **School Board**

Shortly after Mr. Kessler announced his plan to retire July 1st of this year, the School Board took definite steps to commence recruiting his replacement. (The late Dr Robert Stewart of Syracuse University outlined a similar reprocedure three years ago when

case University outlined a similar procedure three years ago when he was the guest speaker at an Alfred meeting of the Southern Tier School Study Council).

A brochure was prepared by Mrs. Slade and slightly modified at a special school board meeting. This described briefly the village and the school. An insert outlined what qualities were desired in a new District Administrator. (Present mandates require a person with sixty (60) hours beyond the Bachelor's Degree with twenty-four (24) of these hours being spent in Administration). An internship of six months as an active assistant to the principal is also desired. desired.

The brochure, an application blank, and a letter of coverage—all of which were printed free of charge at the vocational school—were sent to a number of colleges and placement offices throughout New York and neighboring states. We have received nearly eighty applications. Very few applicants do not qualify—most of the applicants already possess a Doctorate or have nearly completed the requirements for same.

The applications and placement

The applications and placement folders were read and carefully studied by earh board member. This work, of course necessitated two board meetings a week for almost two months. Each applicant was considered for eligibility, experience, and adaptability to the school system. All applicants were then voted upon be each member. The top persons were then controled for interviews. The board has been conducting these interviews for the past several weeks and will soon reach a decision. In most instances, the applicants wives have accompanied their husbands. In this way, they too, are able to view the school and community, and we are able to judge more completely.

Dog Night Quarantine In 23 Counties

Again, it's time to remind the residents of 23 counties of New

Again, it's time to remind the residents of 23 counties of New York State that they cannot allow their dog to run "at large" from sunset to one hour after sunrise, said New York State Department of Agriculture and Markets Commissioner Don J. Wickham.

The night quaranthe has been extended for two more years beginning April 1. 1971 by Commissioner Wickham, at the request of the county legislators.

Enforcement of the night quarantines on dogs is a local matter but they can't legally roam in Allegany, Broome, Cayuga, Columbia, Livingston, Onondaga (except the city of Syracuse), Ontario, Orleans, Otsego, Rensselaer, St. Lawrence, Saratoga, Steuben, Seneca, Tioga, Tompkins, Warren (except the city of Glens Falls), Washington, Wayne and Yates.

Because these night restrictions have been in effect ever since the late 1920's, no new hardships are foreseen for the canine population.

The original purpose of the Dog

late 1920's, no new hardships are foreseen for the canine population. The original purpose of the Dog Law was to protect and foster the livestock industry in the State. The night quarantine provision was designed to keep stary possibly dangerous dogs, from doing harm to domestic animals. However, this provision also helps to protect you and your property.

Violations of the "no night cut" order for dogs in the 23 counties

order for dogs in the 23 counties can be harshly dealt with. The law says that "any peace officer shall kill on sight any dog at large The following books are now available at the Andover Free Library:

"Blooks are now with P. R. and T. in violation of the quarantine. If the owner is with the dog and the dog is under the owner's full control, then the animal is not "at large".
