However, judging from the size of thorn bushes, briars, brush, and growth of wild myrtle, it appears to have been neglected for quite a span of years.

In examining the stones that we have see some were able to get to, here are some of the names that we could make out: James Hann. Esq., Died Apr. 22, 1842. in his 40th yr.; Emma Burdick, died 1845; Rebecca Smith, Burdick, died 1845; Rebecca Smith, Died Mar. 22, 1848, 78th yr. of her age; Alexander Campbell Died Jan. 29, 1868, 72, 5 mo. 23 days; Hepsybah, his wife, Died Aug. 2, 1857, 61 yrs. 2 mo., 1 day; Rosanah Perkins, Died Jan. 14, 1875, aged 98 yrs.; Belle, daughter of P. M. & L. Burdick, Died July 7, 1862.

In talking with Mrs. Sylvia Hardy Reiss McCeubrey, we were told that as a girl she used to visit this cemetery to decorate the graves of her Grandparents, Roswin and Georgiana Hardy, who were early settlers in Andover. However, due to the deplorable condition there, were unable to find any trace of the graves of these early Andover settlers.
