**Richard Burdick Elected Sgt-at-Arms of N.Y.S. Sheriffs' Association**

Belmont — Sheriff Richard C. Burdick of Allegany County was elected Sgt-at-Arms of the New York State Sheriffs' Association at the 37th Annual Conference which concluded last Friday at Coopers-town, N. Y.

Burdick has served as Chairman of the Navigation Committee of the State Sheriffs' Association, which is composed of the sheriff of each county and functions as the governing organization for all sheriff's departments in the state. He will continue his Navigation Committee duties in addition to his new position, according to Sheriff Robert L. Howard of Tompkins County President of the association.

The major address to the sheriffs was made by Robert E. Fischer Deputy Attorney General in Charge of the State's Organized Crime Task Force. "Super Cop" Fischer told the sheriffs that it is important that sheriff's departments take more of an active part in the fight against organized crime. "While gambling is the means of providing the meat and potatoes of organized crime's entrepreneurs, there is no question that narcotics provides the death and destruction we now see invading our schools and our neighborhoods."

Fischer asked the sheriffs: "Are we in the law enforcement structure of our state, prepared to abrogate our historic legal duty to see that the laws of our state are fairly and firmly enforced?"
