Well Taxpayers and Voters, you have been had again! Your lack of legal knowledge and or public interest has lost you the privilege of voting on another matter of interest to all local Taxpayers.

At the regular monthly meeting of the Andover Village Board, a Village Police Justice was appointed at a salary of \$600 a year, and a Deputy. Assistant, or Alternate Justice (call it what you want) will have to be appointed later at an have to be appointed later at an undertermined salary as of this

have to be appointed later at an undertermined salary as of this date.

We are not taking issue at this time over the feasibility, need, or justification of creating these additional offices — only what we feel to be the People's rights to vote on matters where the Taxpayers money is to be spent.

However, this is the second time this year that local Taxpayers have lost their right to vote on what we feel are vital issues. The first time was over the election of three Town Assessors or the appointment of 1 Assessor by the Town Board — which was lost by default with NO LEGAL PUBLIC NOTICE by the Town Board.—And in this last instance where DUE PUBLIC NOTICE WAS GIVEN by Village Officials, it was a case of a petition that was not pertinent to the issue and too late. It seems that legally, a petition had to be submitted within 30 days from the date that the resolution was adopted by the Village Board recuesting a Public the resolution was adopted by the Village Board requesting a Public Village Board requesting a Public Referendum signed by at least 5% of the enrolled or registered Voters of the Village of Andover. And, since this was not done, this resolution was legally adopted.

Since hindsight is always better than foresight, only time will tell whether justice will be best served—or not. 10-4?

In the wake of the Attica prison uprising, rebellion, riot, madness—call it what you may—a few questions have emerged that we would like to see answered.

First—Why was TV Station WGR—Channel 2, the only TV News Media that the prisoners would allow in at the scene of the rebellion?
