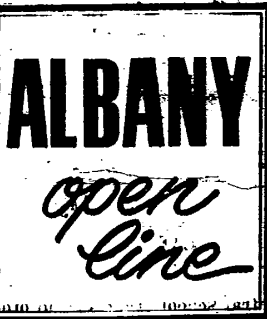
St. Mary's Church in Rexville served an Election Day Turkey Dinner. Several from here helped to serve and prepare and many from Greenwood attended the dinner.

The fat, as they say, is in the fire.

The defeat of the \$2.5 billion mass transportation bond issue recently has brought speculation on both tax hikes and spending cuts at the state level next year.

And the cuts may come earlier than most people expected.

For example, about \$350 million is due local school districts across the state next January and February, partial payments on the annual state aid to schools formula.

Some of those funds may be cut, leaving school districts to make up the difference on their own.

The budget deficit, with the defeat of the bond issue, is now close to \$1 billion.

It is important to note that the deficit is for the current fiscal year, not for the fiscal year which begins April 1, 1972 — that's still another problem.

The fact the deficit is in the current year means that spending will have to be cut in the current year — and since there are only five months left in the current fiscal year, the cuts will be deep and they will hurt local school districts and municipalities.

The \$300 million in the bond issue earmarked for the current state budget was for highway construction. Rockefeller can either cut highway construction or make up the difference somewhere else.

in the budget. It will be hard for him to cut highway construction because some of that \$300 million was for projects which are already underway. Contractors can be expected to tie the state up in lawsuits if the Governor tries to cancel construction contracts.

All of which is going to make this past year's session of the Legislature in Albany seem like an ice cream social compared to the donnybrooks that will mark the coming 1972 session.

The entire state Legislature is up for reelection in 1972. No incumbent legislator is looking forward to raising taxes and cutting state aid to schools at the same time — unless perhaps if he is thinking of retiring.

In general most critics agree that the bond issue was defeated by an anti-spend state and national swing to conservatism and a credibility gap created by the 1967 bond issue, which did not fulfill all the expectations of many of its proponents.
