Notice To Harborers Or Owners Of Dogs

Dog Licenses are due on or before January 1st, 1972. They may be obtained at the Town Clerks' Office.

The taw requires that dogs be licensed by January 1. Faiture to obtain a license subjects the owner to a penalty of \$10.00 and costs and the dog is liable to seizure.

The Commissioner of Health has issued an order requiring all dogs six months of age or over in the County to be vaccinated to prevent rables. Therefore an applicant for a dog license must present to the Clerk a certificate certified by a duly licensed veterinarian showing that the dog has been so vaccinated.

To be acceptable, the certificate presented must show that modified live virus vaccine was used within four years immediately preceding the application date, or that killed vaccine of brain tissue or brain tissue origin was used within the year immediately perceding the application date. the application date.
