The farm is the former Carl Christman farm and is next to the West Union Mennonite Church. The Good respectedly smelled the smoke about 11 p. m., and tried to turn in the alarm from the home. When they called Greenwood, they were so excited they didn't say where the fire was. They then went across the road to

didn't say where the fire was. They then went across the road to the Chinon wheaton residence to turn in the slarm.

Firemen from Rexville, under direction of James Ahearn, and from Whitesville, under the direction of Victor Burch, battled the blaze for more then three hours. They were assisted by men and equipment from Canisteo and Greenwood in Steuben County and Willing in Allegany County. Andover answered the stand-by call at Whitesyille. Eugene Jacobs, Dep-Whitesylle. Eugene Jacobs, Deputy Steuben County Fire Coordin ator, was also at the scene. There were 80 men at the fire.

An adjourned public hearing will be held by the Town Board of the Town of Andover, Allegany County, N. Y., on Thursday, February 18th, 1976, at 7:30 P. M. at the Town Hall on W. Center Street in the Village of Andover, Allegany County, N. Y., to consider the adoption of a proposed Building Ordinance for the Town of Andover, Allegany County, N. Y.

The following is a copy of the said proposed Building Ordinance: Section 1. Application for per-

A. Before the construction or alteration of any building or structure, or any part of either is commenced, the owner or lesse or agent of either, or the architect or builder employed by the owner or lessee in connection with the orne in connection with the pro-posed construction or alter-ation, shall submit to the Town Board a detailed state Town Board a detailed statement of such plans and struc-tural detail drawings of the proposed work, as the Town Board may require, together with a sworn statement of the owner of the use or intended use of such building. All applications, notices and sworn statements required by this ordinance shall be pre-

sworn statements required by this ordinance shall be pre-sented to and kept on file io the office of the Town Clerk. Nothing in this ordinance shall prohibit the filling of amend-ments to any applications at any time before the complet-ion of the work for which per-mit was sought, and such

mit was sought, and such amendments, after approval shall be made a part of the application and filed as such. Ordinary repairs to buildings or structures may be madwithout notice to the Town Roard

Board.
It shall be unlawful to complete or alter any building or structure, or any part thereof until the application and plans required by the provisions of this Article shall have been approved by the Town Brand written complete issued. a written permit issued

and a written permit issued by it.

F. The Town Board shall approve or reject any application or plan or amendment thereto filed with it pursuant to the provisions of this Article within a reasonable time, and if approved, shall promptly issue a permit therefor.

hundred percent (100%) of the
existing cubical contents of the
building shall be erected, and provided that such extension or addition shall be made in conformity
with the provisions of Section 1
of this ordinance, pertaining to
application for building permits. of this ordinance, pertaining application for building permits. Section 3. Reversion of use.

If a nonconforming building or If a nonconforming building or use, existing at the time this ordinance shall become effective, is subsequently changed to a conforming use, or is destroyed by fire, explosion, Act of God, or the public enemy, to the extent of more than seventy-five percent (75%) of its assessed valuation, such building or use shall not again be altered or rebuilt, except in conformity with the rules and regulations of the district in which such building is located.

Section 4. Building Inspector.

The Town Board, if it desires may appoint a Building Inspector to assist in carrying out the provisions of this ordinance, and shall prescribe his powers and duties as such Inspector, and his compensation, if appointed, shall be a charge against the Town.

Section 5. Board of Appeals.

a Board of Appeals of three
(3) members, who may, but
need not be Trustees, each to
be appointed for three
(3)
years, and such Board of Appeals shall have all the powers
and duties given and prescribed by the Town Law of the
State of New York.

Where there are any practical difficulties in the way of difficulties in the way of carrying out the strict letter of any provision of this ordin-ance, or where unnecessary hardship would thereby result to the owners of property, the Board of Appeals shall have power in a specific case, after due notice and public hearing to vary any such provision in harmony with the general purpose and intent of this ordinance, so that the public health, safety and general welfare may be secured and substantial justice done, and to this end, may permit. to this end, may permit, among other things:

The granting in undeveloped sections of the Town of temporary and conditional permits of not more than one (1) year's duration for structures and uses not permitted by this ordinance. mitted by this ordinance but which are necessary to the development of such ections.

The granting of special permits for the location within the Town limits of a limited number of grocery stores, delicatessens, and other similar businesses cus-tomarily found in residen-tial sections provided the location of such business does not interfere with the declared purpose of conserv-ling property values in that ing property values in that locality, and provided that the building or structure from which said business is conducted is of approved modern design and equipment. ment.

The Board of Appeals shall have power to reject and reverse any order, decision or approval of the Building Inctor

Section 6. Amendments.

The Town Board may from time petition, after public notice and hearing, amend, supplement, or change the regulations and uses herein established, and adopt rules and regulations for the purpose of construing, interpreting and carry-ing into effect this ordinance.

Section 7. Violations and pen-

Every agent, architect, build-ing contractor, owner, tenant or other person, having charge of any_building or lands, who commences, takes part in or assists in any violation of any of the provisions of this or-dinance, or who constructs maintains or uses any building or structure or premises, in upon or by which any provis-ion of this ordinance is violated continues, be suject to a fine of not more than Twenty-five (\$25.00), and in addition thereto, any such violation of any to, any such violation of any of the provisions of this ordinance shall constitute disorderly conduct, and any person violating any provision of this ordinance or orders made pursuant thereto, shall be a disorderly person, and may be purished by a fine or not more than Twenty-five dollars (\$25.00) and each and every than Twenty-tive cousing (\$25.00), and each and every day a violation of this ordinance is committed or permitted to exist, shall constitute a separate offense, after receiving notice to cease or

receiving notice to cease or remedy such violation. remedy such violation.

Whenever the Supervisor of
the Town shall certify that
any building or any part
thereof, or any lands are being
erected or used in violation
of the provisions of this ordinance, the Town Attorney is
authorized to institute all
actions and proceedings,
either level or ceutishle that actions and proceedings, either legal or equitable, that may be appropriate or neces-sary for the enforcement of the provisions of this ordin-ance.

Section 8. Validity.

The invalidity of any section or provision of this ordinance shall not invalidate any other section or provision thereof.

Section 9. Repeal of conflicting ordinances.

All ordinance and parts of ordinance heretofore passed, which are in conflict with this ordinance, are hereby repealed.
