Further, petitioner is a licensed dentist. He is continually being called Dr. Campbell in error. He believes that the resumation of his true family name will make others aware of the correct spelling and pronunciation of his last name.

5. Your petitioner is a citizen of the United States of America.

A LOCAL LAW TO AMEND LOCAL LAW NUMBER ONE OF NINETEEN HUNDRED SEVENTY-FIVE IN RELATION TO REPORTING TIME AND TERMINATION OF TEMPORARY COUNTY COMMISSION TO STUDY YOUTH PROGRAMS AND SERVICES IN ALLEGANY COUNTY

BE IT ENACTED by the Board of Legislators of the County of Allegany as follows:
