A PUBLIC HEARING ON PROPOSED BUILDING ORDINANCE FOR TOWN OF ANDOVER, ALLEGANY COUNTY, N. Y.

A PUBLIC HEARING will be held by the Town Board of the Town of Andover, Allegany County, N. Y., on Tuesday, December 30th, 1975 at 7:00 P. M., at the Town Hall on W. Center Street in the Village of Andover, Allegany County, N. Y., on the adoption of a proposed Building Ordinance for the Town of Andover, Allegany County, N. Y.

The said proposed Building Ordinance is set forth as follows:

Section 1. Application for permits.

A. Before the construction or alteration of any building or structure, or any part of either is commenced, the owner or lessee or agent of either, or the architect or builder employed by the owner or lessee in connection with the proposed construction or alteration, shall submit to the Town Board of the Town of Andover, a detailed statement of such plans and structural detail drawings of the proposed work, as the said Town Board may require, not required outside the flood prone area together with a sworn statement of the owner of the use or intended use of such building, and will be issued automatically outside of the flood prone area.

B. All applications, notices and sworn statements required by this ordinance shall be presented to and kept on file in the office of the Town Clerk of the Town of Andover.

C. Nothing in this ordinance shall prohibit the filing of amendments to any applications at any time before the completion of the work for which permit was sought, and such amendments, after approval, shall be made a part of the application and filed as such.

D. Ordinary repairs to buildings or structures may be made without notice to the Town Board, up to 25% (twenty-five percent) of full valuation.

E. It shall be unlawful to complete or alter any building or structure, or any part thereof, until the application and plans required by the provisions of this Building Ordinance shall have been approved by the said Town Board and a written permit issued by it.

F. The said Town Board shall approve or reject any application or plan or amendment thereto, filed with it pursuant to the provisions of this Building Ordinance, within 45 days (forty-five days), and if approved, shall promptly issue a permit therefor.

G. Any permit issued by the said Town Board under the provisions of this Building Ordinance, but under which no work is commenced within one (1) year from the time of the issuance, shall expire by limitation.

H. The said Town Board may reject any permit or approval issued under the provisions of this Building Ordinance, in the case of any false statement or misrepresentation as to a material fact in the application on which the permit or approval is based.
