### Village Board Holds Regular Meeting

The regular monthly meeting of the Board of Trustees was held in the Village Office, Tuesday, July 17th at 7:30 p. m. - Present: Ralph A. Allen, Mayor; Karl Graves and Ann Appier, Trustees; Superintendent, Barry Robrabacher; Police Sergeant, James Graffrath; Maynard Towner, Connad Church RoseMary Burger, and Edith Wallace from the Andover Chamber of Coramerce.
